MONTH LONG MEMBERSHIP DRIVE

FPA is having a month long membership drive celebrating our 27th anniversary of airing community programming. All FPA members are encouraged to have a friend or relative join us and, as a thank you, will be able to choose one of a number of prizes – a gift pack of hat, pens and an FPA pin (while supplies last), 3 hours of free dub time, a single back-to-back studio booking in advance or field scheduling more than 2 months in advance, or a staff-created TV promo for your show. The membership drive kicks off on May 11, with a special live program from FPA that will give viewers a look at our studios and equipment, designed as a way to intrigue potential members to see the possibilities waiting for them at FPA. The show "FPA Presents: TV, Radio & You" will air live at 9pm, Wednesday May 11, with repeats later in the month, so spread the word and tune in.

The membership drive ends at the close of Celebrate Fairfax, where FPA will host a booth so you've got until June 12 at 6pm to get those new members signed up.

FPA INSTRUCTOR'S DOC AIRING IN MAY

One of FPA's Field Package instructors, Adele Schmidt, will be airing her documentary "Romantic Warriors – A Progressive Music Saga" this month over WHUT, Howard University Television, Channel 32. The 95 min. documentary is an engrossing look at the progressive music scene, both past and present, and features interviews shot here at the station with FPA's own Debbie Sears, host of Radio Fairfax's "Prog- Rock Diner. " The documentary airs Thursday May 19 at 10pm, Sunday May 22 at 8pm and Tuesday May 24 at 9pm, and is a must-see for prog fans, those interested in experimental music and the scene surrounding it, or anyone interested in seeing Deb in action on-air. CONTEST OF THE QUARTER

We're looking for the top Channel 10 TV producer, not in quantity of programs, but for quality in technical areas of expertise. To be eligible for consideration, you must be an active producer who:

- 1. Produces their show with FPA equipment or facilities.
- 2. Submits a show that was taped in 2011 and aired on Channel 10.
- 3. Has a regular time slot (specials are ineligible for consideration).

Shows submitted will be judged by a panel of staff members according to the categories of lighting, camera work, editing or a combination of all three, as chosen by the producer on submission. Each producer may enter only one program for consideration, even if they produce more than one series at a time. Staff productions are eligible only if the category chosen by the producer at submission was not done by staff in the course of that production. Production Manger Lisa Clarke will be accepting entries through May 31, with the winner announced in the July newsletter. The top producer will have a certificate on display in the FPA facilities throughout the quarter (after which it will be presented to the winner) and be recognized at the FPA Annual Meeting in September. All entries must be in DVD format, and accompanied by a submission form, found outside of Lisa's office. So good luck, and let's see what you've got!
